Schedule scans by date and time, site depth, and exclusions or inclusions of compliance checks. Configure scans to easily scan behind both age gates and basic authentication pages.

Auto-categorize trackers once categorization is applied on subsequent scans for each registered website URL and its scanned pages.

Monitor websites persistently

Address areas of tracker non-compliance by monitoring websites for compliance issues throughout their lifecycle and summarizing potential issues in scan reports.
